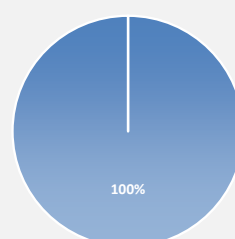

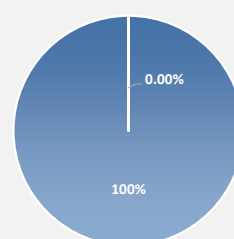
Geographical Distribution

Fund Ownership Investment

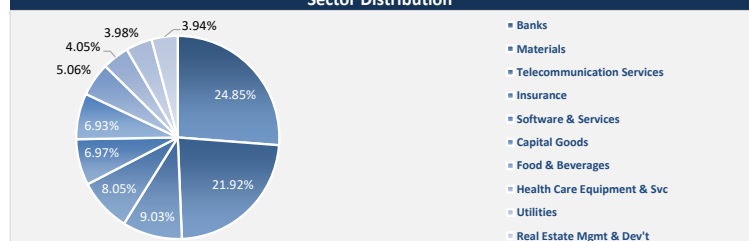
Full ownership Right of benefit



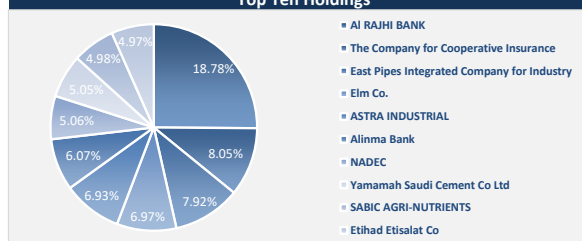

Sector Distribution *

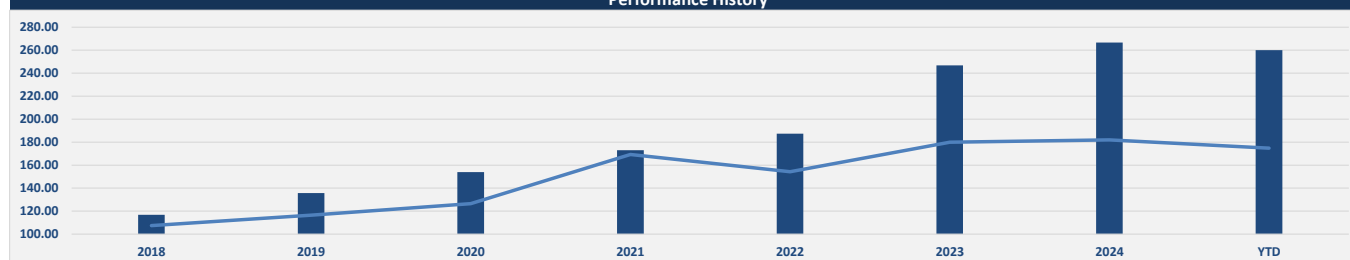


Top Ten Holdings *
