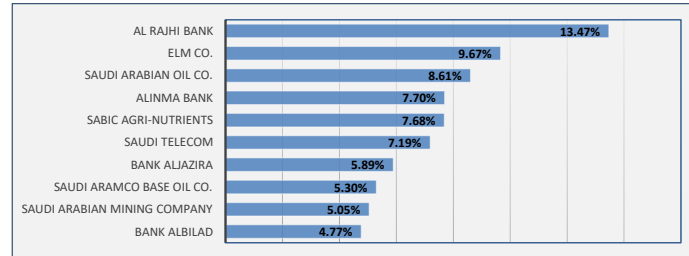

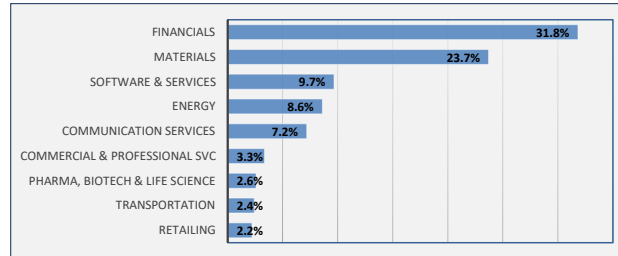

## i Top Ten Holdings



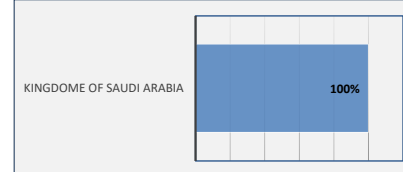

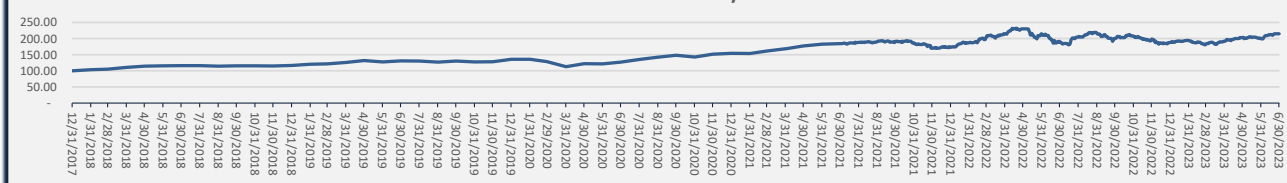
