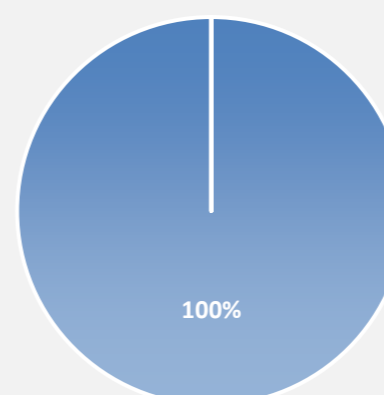

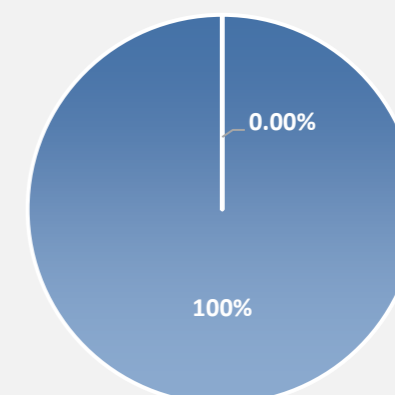
Geographical Distribution

Kingdom of Saudi Arabia

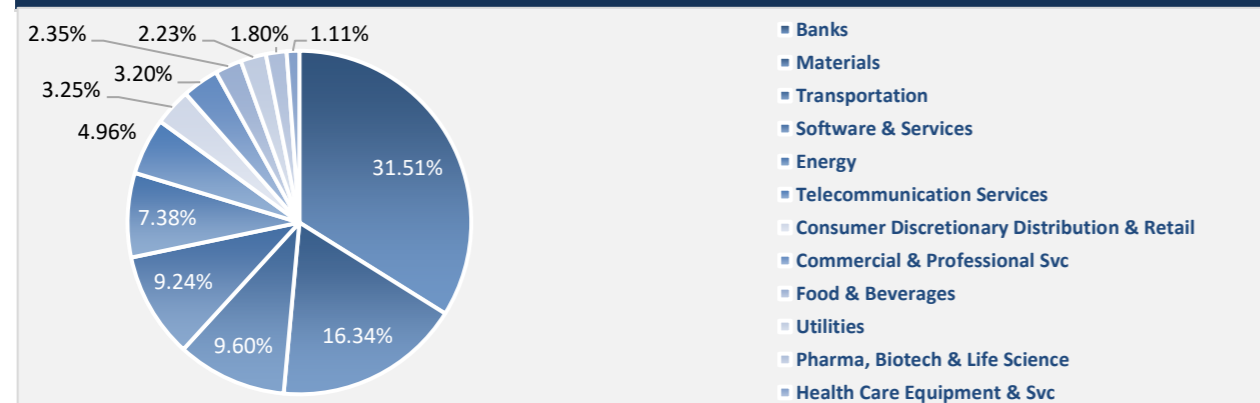


Fund Ownership Investment

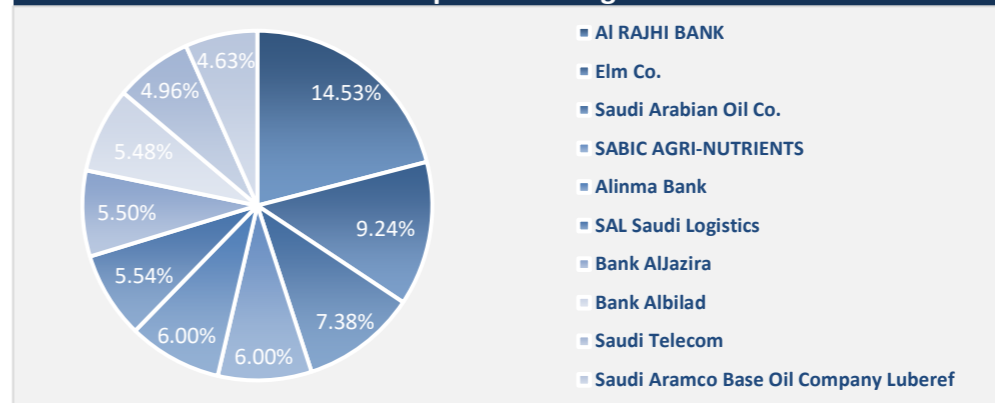
Full ownership Right of benefit



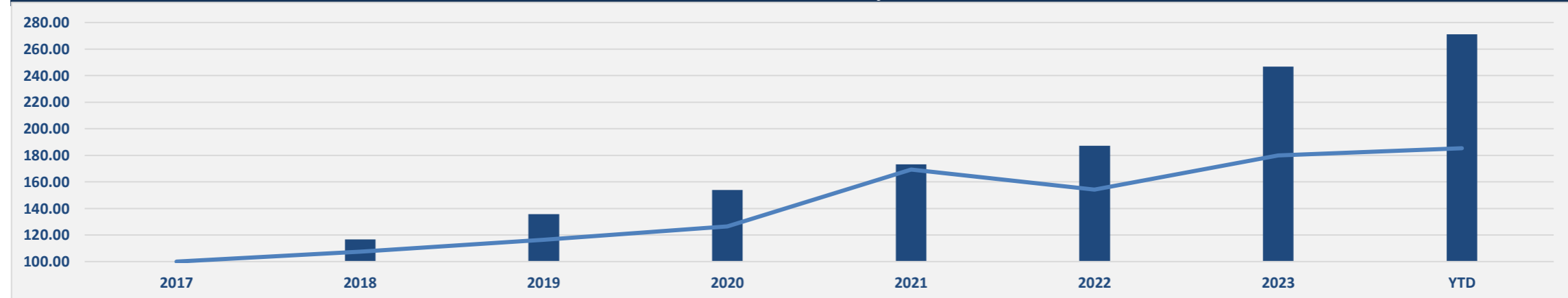
Sector Distribution
